# General policies of dominion name

The Registry of names of dominion under ccTLD .MX, this delegate to the Technological Institute and of Studies Superiors of Monterrey, Monterrey Campus ("ITESM") by IANA (Internet Assigned Numbers Authority) duty carried out at the moment by ICANN (for Internet Corporation Assigned Yams and Numbers), according to the principles contained in document RFC 1591 and is administered by Mexico Network Information Center, S.C. ("Registry .MX"). This relation, between the ITESM and Registry .MX, was established in November of 2003 to carry out the functions related to the administration and registry of the names of dominion under ccTLD .MX.

### Definitions

1.1 Authority
Any person had with being able, faculties and/or jurisdiction sufficient to exert the command function, directed to obtain the fulfillment of subjects related to these policies, procedures and their modifications or replacements, as well as any group of experts, referee, organism or by arbitration panel before those who the parts had been put under taking care of the policies and procedures described here

1.2 <u>ccTLD</u>
Used abbreviations to designate to the names of dominion of first level, known like territorial codes (Country Code Top Level Domain). These abbreviations talk about to the classification in the System of Names of Dominion, represented by a suffix of two letters, assigned according to the codes standard of ISO3166-1 for the representation of names of countries or territories.

### 1.3 Contacts

Created objects to facilitate the administration of a Name of Dominion. Three types of contact for each Name of Dominion exist: office staff, technician and of payment. Each contact has assigned a called identifier NIC-ID.

1.7 Name of Dominion

1.8 Political It bases
The General Policies of Names of Dominion, Policy of solution of controversies in the matter of names of dominion for .MX (LDRP) and the Regulation of the policy of resolution of controversies in the matter of names of dominion for .MX, published in the Web site of Registry .MX (www.registry.mx).

1.9 Registrante
To title and person in charge of the Name of Dominion. It is recommended that he is
the end user (physical or moral person) of the Name of Dominion. The Registrante
object will have assigned a called identifier YOU PREVAIL.

## 1.10 To register

Physical or moral person, credited to distribute and to offer services of administration of Names of Dominion.

The terms defined in this section could as much be used in the present Policies in singular as in plural.

All the headed used in the present Policies are used exclusively to facilitate their reading, but they will not be taken into account in the interpretation from the same.

2 General dispositions
The applicant, the Registrante and the Contacts of a Name of Political Dominion declare that they know and accept the Base, procedures, regulations and Annexes in relation to the name service of Dominion, including their registry, modification, suspension, cancellation, transference and disputes.

Registry .MX simply is administering the space of Names of Dominion, and therefore, any consequence derived of the registry and/or use from Names of Dominion that constitutes or could constitute violations to the applicable legislation, are exclusive responsibility of the Registrante of the Name of Dominion

Any modification or update to these Policies will be published with a warning of at least

15 (fifteen) Days immediate previous to the date of their entrance in force, in the Web site of Registry .MX (www.registry.mx), so that Registrar, the Registrante and/or the Contacts show what to his interest it agrees. Once passed the previous term Registrar, the Registrante and the Contacts of the Name of Dominion will be forced under these new Policies, without it is necessary that Registry .MX realises no other type of publication or warning

The present Policies could be modified or be replaced listening to the commentaries and opinions sent by the External Consultative Committee, being effective within at least 15 (fifteen) Days later to the publication of the proposal of modifications in the Web site of Registry .MX (www.registry.mx), so that Registrar, the Registrante and/or the Contacts show what to his interests it agrees. Once passed the previous term Registrar, the Registrante and the Contacts of the Name of Dominion will be forced under these new Policies, without it is necessary that Registry .MX realises no other type of publication or warning.

All the communication will be in Spanish language; nevertheless Registry .MX will be able to answer messages originally written in a language different from the Spanish to consider it thus necessary.

Registry .MX will be able to register, to modify, to renew, to eliminate, to transfer and/or to suspend a Name of Dominion by resolution emitted by some Authority.

### Basic operations of Names of Dominion

In Registry .MX, the Registrars they can carry out the following basic operations of Names of Dominion:

- Registry
- Modification
- RenovationElimination.
- Transference

Registrar of a Name of Dominion is unique the authorized one to realise anyone of the previous operations before Registry .MX, whenever estatus of the Name of allows it to Dominion. If the Registrante and/or the Contacts of a Name of Dominion wish to realise anyone of these operations, will have to ask for this service by means of Registrar, that will have to provide the service to the Registrante and/or the Contacts of the Names of Dominion that it administers.

By the previous thing, Registrar when carrying out these basic operations will make sure to count on the authorization of the Registrante, whenever it is necessary

Registrar, the Registrante and the Contacts accept and recognize that it is his obligation maintaining his information and the one of the Names of Dominion with which they have relation, updated in the data base of Registry .MX.

Next one describes each one of the basic operations of Names of Dominion:

### 3.1 Of the registry of Names of Dominion.

By the acceptance that Registry .MX does of a request of registry of a Name of Dominion is clear the right of the holder (Registrante) the use, we enjoyed and enjoys the Name of Dominion by the paid time of cover, without by the previous thing it is understood the transmission and/or cession of the rights of property of the same. The maximum time of cover of the Names of Dominion is published in the Web site of Registry .MX (www.registry.mx).

He is requisite indispensable to provide the data that Registry .MX requires of the Registrante and the three Contacts (administrative, technical and of payment) when soliciing a Name of Dominion. Some classifications of Names of Dominion will be able to have additional requirements for their registry, in accordance with the established thing in Annex A.

Registry .MX will only accept requests of registry under the classifications established in Annex A. The classifications of the Names of Dominion can increase, change or fall, previous warning of Registry .MX through their Web site.

### 3.2 Of the modification of Name of Dominion.

The modifications of Name of Dominion are any change or update to the data of a Name of Dominion.

The modifications that can be realised to the Name of Dominion are:

- Change of Registrante.
   Change of Contacts:
   Office staff,
   Zentalician, and/or
- Of Payment.
   To add, to eliminate or to modify Servants of Nombres (DNS).
- iv. Estatus that can be modified by Registrar.
- Information of Authorization.
  Change of the information of Contacts and the Registrante.

Under no circumstance the name of a Name of Dominion will be able to be modified.

## 3.3 Of the renovation of Name of Dominion.

The extension of the use of this one by one or more years of cover is understood by renovation of Name of Dominion. The maximum terms of renovation of the Names of Dominion are published in the Web site of Registry .MX (www.registry.mx).

3.4 Of the elimination of Name of Dominion.

By elimination of Name of Dominion the incapacitation is understood of the Name of Dominion to be solved by the DNS, being this Name of Dominion available to be registered by a third party

**3.5** Of the transference of Name of Dominion.

By transference of Name of Dominion the change is understood of the administration of a Name of Dominion from Registrar to another one.

It is necessary to provide to Registry .MX the Information of Authorization of the Name of Dominion to be able to initiate a request of transference of the mentioned Name of Dominion. Also, the applicant, the Registrante and the Contacts recognize and accept that when completing itself a transference of Name of Dominion, this Name of Dominion will renew automatically by a year more of cover, whenever this is possible.

# Suspension and elimination of Name of Dominion on the part of

Registry .MX.
Registry .MX will be able to suspend and/or to eliminate a Name of Dominion when:

- The Name of Dominion is not paid by Registrar.
- By requirement of Authority.

  Registry .MX needs to contact with Registrar related to a Name of Dominion, and this it would not respond to official notices of Registry .MX within the required term. In this case the Name of Dominion could be

- suspended and/or be eliminated.
- The information of the Registrante and/or the Contacts, and/or the one of the Name of Dominion one is not updated that is false.

  The Registrante and/or the Contacts of the Name of Dominion do not fulfill
- Political the Base.

### It disputes and It complains a Name of Dominion.

Registrar will be the person in charge to transact and to provide solution the problematic ones that they are gotten to provoke with relation of the Names of Dominion that it administers.

One says that a dispute of Name of Dominion exists when a third party creates to have straight better on the ownership of a Name of Dominion that the present holder. Two types of disputes of Names of Dominion exist:

i. Dispute by ownership.

a) This dispute is due to carry out when a person considers that the

  a) For the resolution of any controversy derived from some violation to rights of intellectual property (product registered tradename or services, registered commercial warnings, denominations of origin, reserves of rights) they will be applicable the Policy of Solution of Controversies in the matter of Names of Dominion for .MX (LDRP) and the corresponding Regulation.

Despite the previous thing, the Registrante, the Contacts, Registrar and/or any third party will be able to interpose a complaint before Registry .MX whenever it considers it necessary, in relation to the Name of Dominion.
